



Child Care Area Rules and Regulations

1. The child care area shall provide child care services.
2. Child care services shall be provided for the children aged 1 to 14 whose parents use the recreational services of the Druskininkai Aqua Park.
3. The purchase of the child care services shall be registered in the electronic bracelet of the child's parents or other responsible persons. The payment for the services shall be made at the exit register.
4. Children aged 1 to 3 shall be allowed to use the services of the child care area only under the supervision of one of the parents or other responsible adult person.
5. Child care services shall be provided free of charge only for those children whose parents or other responsible adult persons have purchased a ticket to the aquatic entertainment or bathhouse area Alita (Parts B + C) or are the guests of the Hotel Aqua Medūna.
6. Free of charge services shall be provided for the children aged 1 to 14 for the duration of 1 hour as a one time visit during the validity of their ticket.
7. Visitors of the Aqua Park who possess a valid season pass, shall be charged for all child care services available.
8. Prices for the child (aged 1 - 14 years) care services:
 - supervision of one child for up to 30 minutes – 5.00 LTL;
 - supervision of one child for 1 hour – 8.00 LTL;
 - supervision of one child for extra time (1 - 30 minutes) – 5.00 LTL
 - supervision of a group of children (5 children and more) for up to 15 minutes – 3.00 LTL for each child in the group.
9. The parents or other responsible persons who have left their children in the child care area for an estimated period of time, shall pick up the children once that period is expired.
10. If the parents or other responsible persons who have left their children in the child care area, do not pick them up at the expiry of the period they paid for, the additional time shall be calculated for every 1 - 30 minutes.
11. Upon the request of the parents or other adults responsible for the children, they shall be permitted to stay together with the children in the child care area.
12. Children with disabilities shall be allowed to use the services of the child care area only under the supervision of one of their parents or other responsible adult person.
13. The parents or other adults responsible for the children who leave their children at the child care area, shall inform the employee of the child care area about the period of time they intend to leave the child for, and shall indicate how the parents could be located.
14. The children are obliged to comply with the Rules and Regulations of the Druskininkai Aqua Park and follow the instructions of the persons working at the child care area.
15. The children left at the child care area shall be properly dried with a towel.
16. The children shall wear no slippers or any other kinds of shoes.
17. Children below the age of 3 shall be permitted to the premises of the child care area only wearing a diaper.
18. The children shall be prohibited to chew chewing gum, to bring along and consume food and drinks.
19. The children shall be prohibited to push others, to be rude to others and to create dangerous situations to themselves and other children.
20. The children shall be prohibited to bring along items, which are not essential for their stay at the child care area.
21. It is strictly prohibited to touch electronic devices, cords and other mechanisms at the child care area.
22. The attractions available at the child care area shall be used as indicated by the child care area employee.
23. The children who do not obey the instructions of the child care area employee and do not comply with the present Rules and Regulations, shall be returned to the care of their parents or other responsible persons, once they are located. There shall be no refunding for the purchased time that was not used.
24. The children shall not be admitted to the child care area 30 minutes before the closing time of the Aqua Park.
