 - 2.1.7 The right to object the processing of personal data;
 - 2.1.8 The rights related to not being subject to a decision based solely on automated processing, including profiling.
- 2.2 In case you would have any complaints, you may contact us directly or to make a complaint with the State Data Protection Inspectorate, according to the procedures described in the legislation.

3. What data we collect?

- 3.1 In order to ensure effective browsing and to provide you beneficial offers, we use the following cookies in our website: "XSRF-TOKEN" (to improve safety of the application), "laravel_session" (for session generations), "extend_reservation_in" (to ensure the reservation time), "agree_with_cookies" (for client's agreement with cookies' policy) "_ga" and "_gid" (Google Analytics).
- 3.2 If you contact us by e-mail, we will process involved data.

4. How we process your data?

- 4.1 In cases when we collect personal data, it is processed and stored only as long as it is necessary for the purpose that it is intended to be used.
- 4.2 Your personal data may be used to:
 - 4.1.1 Reply to your requests;
 - 4.1.2 Ensure effective browsing in www.akvapark.lt
- 4.3 All e-mails are deleted in 6 months after the respective issues were solved.
- 4.4 You have the right to revoke the permission to process your personal data at any time.
- 4.5 We will not disclose any identifying personal data, to any third party, for any purpose whatsoever, except your e-mail address if you agree to receive newsletters.

5. Keeping data safe

- 5.1. We process your data as long as it is necessary and only with your consent.
- 5.2. Your data is stored in server, which is the territory of the Republic of Lithuania.
- 5.3. Data safety is our top priority and we employ every available instrument: encrypted information between client and server (HTTP and SSL certificates), firewalls, continual safety inspection, regular DNSBL checks.

Your personal data will be processed fairly and lawfully, in compliance with the provisions of the Law on Legal Protection of Personal Data of the Republic of Lithuania and other legislation. The company has set up physical, technical and administrative security measures to protect of your personal data from accidental or illegal corruption, modification, disclosure and any other illegal processing.
